**STOP PRESS – EASTER
SALE**

As we go to print the first day of the Easter Sales have passed. It seems to have been a well anticipated Easter Sale and results of the first day had 5 yearlings breaking through the million dollar mark. The top yearling was a \$2 million Redoutes Choice colt with 4 other yearlings going for between \$1.4 and \$1.6 million. These figures saw the average yearling price rise 15.6% to \$296,950.

Of the 241 catalogued yearlings 18 were withdrawn, and out of the 223 left, 57 or 25.5% were passed in. Therefore 1 in 4 didn't find a buyer. Of the 26 yearlings that were sold under \$100,000 their average was steady at \$69,230. What does this all mean? The international buyers were after the premium lots and only Woodlands Stud and Crown Lodge were competing at these price levels. Vendors also are

setting unrealistic high reserves in the middle market. Being the first day it was obvious that the large normally active stables were not about. We will report on completion of the sale a further summary and report on sales figures and statistics.

**HOT ISSUES –MEETING
WITH GREG RUDOLPH
GENERAL MANAGER –
COMMERCIAL (RACINGNSW)**

On the 3rd of April the Board called on the General Manager - Commercial (RacingNSW) Mr Greg Rudolph to address current racehorse owner issue's and update the Board on commercial issues at RacingNSW. The relevant points of interest are summarized below;

• **BOBS** – Greg Rudolph highlighted in his discussions with the NSWROA that they are currently investigating a number of financing models to improve the BOBS Scheme. Max Whitby (NSWROA) highlighted the need for individual owner accounts for BOBS so participants can use their Voucher share. Greg Rudolph said they would be targeting syndicate's better in making Double Ups better known, and that they can be taken as a share value.

• **Handicapping** – Greg Rudolph stated that the Handicapping department is now in a consultation phase with trainers on the Ratings Based Handicapping (RBH) System. He feels that the RBH System wasn't particularly marketed well to industry participants and hasn't been assisted with the loss of a

key staff member. RacingNSW are committed to the RBH System however admits that a more equitable points scale and handicapping template is necessary. On completion of the consultation phase and review of the template, RacingNSW are aiming to attract more provincial and country horses to race in the metropolitan area.

• **Jockey Sponsorship** – The Committee reiterated to Greg that the Racehorse Owners should have been consulted prior to Jockeys sponsorship. The NSWROA position is that they are using the 'Owners Product' to promote their client and personally benefit and reward from.
